

COMPLAINT FOR COPYRIGHT INFRINGEMENT

Plaintiff, Alex Grey ("Alex Grey") by his attorneys, complaining of the Defendants Juan Fernandez and mysticmania.com (hereinafter, collectively "Defendants"), on knowledge as to the Plaintiff and otherwise upon information and belief, alleges as follows:

NATURE OF ACTION

- 1. This action is brought by Plaintiff for copyright infringement under the Copyright Act of 1976, as amended, 17 U.S.C. Sec. 101 et seq. ("Copyright Act").
- Defendants have placed on the Internet reproductions of Plaintiff's artwork that infringes on registered copyrights of Plaintiff.

JURISDICTION AND VENUE

- This action for damages brought under the Copyright Act raises "federal questions", and 3. the jurisdiction of this Court is founded upon 28 U.S.C. Sections 1331, 1338 and 1332.
- Venue is proper in this District under 28 U.S.C. Sections 1391 and 1400 and the Court 4. has personal jurisdiction over Defendants because Defendants personally reside and operate companies subject to personal jurisdiction in this District and are therefore deemed to reside here for purposes of venue. Defendants have also engaged in and committed the acts herein complained of in the State of New York and in this District causing injury to Plaintiff and his intellectual property rights within the State of New York and in this District.

PARTIES

5. The Plaintiff is an individual located in the State of New York and resides at 725 Union Street, Brooklyn 11215. Defendant, Juan Fernandez is an individual who resides at 235 54th Street, Brooklyn, New York 11220 and mysticmana.com is a business whose principal address is 235 54th Street, Brooklyn, New York 11220.

BACKGROUND FACTS

In 1972 Alex Grey began his painting career, creating works of art that have been 6. described as an unusual and contemporary blend of sacred or visionary art and postmodern art. His work depicts aspects of the supernatural overlaid with aspects of the natural world.

- 7. Alex Grey paintings have been featured in venues as diverse as the album art of Tool, SCI, the Beastie Boys, and Nirvana, in *Newsweek* magazine, and on the Discovery Channel. His work has been exhibited worldwide, including at the Feature, Inc, Tibet House, Stux Gallery, PS 1, New York Museum, Grand Palais in Paris, Baltimore's American Visionary Art Museum, the Museum of Contemporary Art in San Diego in the 1999 Sao Paulo Biennial. Alex Grey has been a keynote speaker and participant at conferences all over the world including conferences in Tokyo, Amsterdam, Switzerland, Spain and Brazil.
- 8. The book, Sacred Mirrors: The Visionary Art of Alex Grey, has been translated into five languages and has sold over one hundred thousand copies, unusual for an art book. The New York Times hails "Grey's vision of a flawed but perfectible mankind stands as an antidote to the cynicism and spiritual malaise prevalent in much contemporary art."
- 9. His inspirational book, *The Mission of Art*, traces the evolution of human consciousness through art history, exploring the role of an artist's intention and conscience, and reflecting on the creative process as a spiritual path. *The Mission of Art* is an inspirational text for artists and anyone who has glimpsed the spiritual power of art. Alex Grey traces the evolution of human consciousness through art history, seeking the threads of art's essential meaning. He reflects on the development of his own work and explores the role of an artist's intention and conscience, and how we can draw on the creative process for spiritual growth.
- 10. The large format art book, *Transfigurations* is Alex Grey's second large-format monograph, containing over 300 color and black & white images of his work.

- 11. For the past 17 years Alex and his wife Allyson Grey have conducted a Visionary Art Intensive for one week during the summer at Omega, a pioneer institute of learning in located in upstate New York.
- 12. Sounds True has released *The Visionary Artist*, a CD of Alex Grey's reflections on art as a spiritual practice, and in 2006, *CoSM the Movie*, a full length documentary about Alex Grey and the Chapel of Sacred Mirrors, was released.
- 13. Alex Grey has chosen a unique path for such an accomplished artist. Believing in the vision of building sacred space that reflects humanity's journey in the 21st century, Alex Grey, along with his wife, Allyson, founded the Foundation for the Chapel of Sacred Mirrors ("CoSM"), a non-profit 501(c)(3) organization dedicated to building a sanctuary for contemplation and a center for events encouraging the creative spirit. CoSM is presently located in Chelsea in Manhattan, and is planning a permanent home to be located in upstate New York.
- 14. The centerpiece of CoSM is a unique series of 21 life-sized paintings, taking the viewer on a journey of their own divine nature by examining, in detail, the body, mind, and spirit. Begun in 1979, the series took ten years to complete. The Sacred Mirrors consist of nineteen paintings and two mirrors that examine in fine detail the human physical and metaphysical anatomy. Each image is forty-six by eighty-four inches and presents a life-sized figure directly facing the viewer, arms to the side and palms forward. This format allows the viewer to stand before the painting figure and "mirror" the image. A resonance takes place between one's own body and the painted image, creating a sense of "seeing into" oneself. The Sacred Mirrors also is a tool to visualize and focus healing energy to particular parts of the physical and metaphysical bodies.

- 15. CoSM houses an additional 50 pieces of Alex Grey artwork as well as many pieces created by Allyson Grey. The gallery also exhibits the work other artists.
- 16. CoSM's Board of Advisors includes Deepak Chopra, Ken Wilber, and Mariel Hemingway. CoSM has become a community for many thousands of people who come to the Chapel for weekly events, seminars, and workshops.
- 17. Plaintiff is and, at all times relevant to the matters alleged in this complaint, has been engaged in creating and producing works of art and managing CoSM.
- 18. Among the paintings of Alex Grey, many of which are part of the Sacred Mirrors are Cardiovascular System, Psychic Energy System, Sophia, Spiritual Energy System, Universal Mind Lattice, Christ, Kissing, Pregnancy, New Family, Dying, Gaia, Journey of the Wounded Healer, Theologue, Holy Fire, Collective Vision, Cosmic Christ, Despair, Namaste, Light Weaver, Nature of Mind, Wonder, and New BardoBeing.
- 19. Plaintiff's artwork as set forth in paragraph 18 is wholly original with Plaintiff and is copyrightable under the laws of the United States.
- 20. On or about January 2, 1991, Inner Traditions International applied on behalf of the Plaintiff to the Register of Copyrights for a Certificate of Registration for Sacred Mirrors: The Visionary Art of Alex Grey containing the images of Cardiovascular System, Psychic Energy System, Sophia, Spiritual Energy System, Universal Mind Lattice, Christ, Kissing, Pregnancy, New Family, Dying, Gaia, Journey of the Wounded Healer, Theologue, Holy Fire. The Certificate was issued by the Register of Copyrights effective as of January 2, 1991 and bears the registration number PA 488-516. A true and correct copy of the Certificate is attached hereto as Exhibit 1.

- On or about March 29 2002, Inner Traditions International applied on behalf of the 21. Plaintiff to the Register of Copyrights for a Certificate of Registration for Transfigurations containing the images of Collective Vision, Cosmic Christ, Despair, Namaste, Light Weaver, Nature of Mind, Wonder, New Born, One, Oversoul, White Light, Artists Hand. The Certificate was issued by the Register of Copyrights effective as of March 29 2002 and bears the registration number TX 510-835. A true and correct copy of the Certificate is attached hereto as Exhibit 2.
- Plaintiff is currently and at all relevant times has been the sole proprietor of all right, title 22. and interest in and to the copyright in all of the works of art set forth in paragraph 18.

DEFENDANTS' CONDUCT

- Defendants appear to be in the business of selling reproductions of artwork and other 23. related merchandise on the Internet.
- To the best of Plaintiff's knowledge and belief, Defendants purchased posters and 24. calendars from CoSM containing images of Alex Grey's copyrighted artwork as set forth in Paragraphs 20 and 21. Defendants then repurposed the artwork to sell it on the Internet, undertaking among other things mounting the images on wood backing and framing individual pieces. In the process of their selling of the artwork, Defendants copied and reproduced the artwork from copyrighted images and has in the past and is presently displaying and distributing the reproductions on the Internet, on Defendants' own website and on other websites such as Amazon and eBay. See Exhibit 3.
- 25. On or about July 23, 2007, Plaintiff, through counsel, communicated with Defendants detailing his belief that Defendants' conduct was an infringement of copyright.

- On or about July 25, 2007, Defendants responded indicating that it was their belief that 26. no infringement had taken place.
- After conversations with Plaintiff's counsel and a request to meet personally with Alex 27. Grey, Defendant Juan Fernandez met with Alex Grey in August 2007. In their conversation, Plaintiff made it clear that the artwork was owned and copyrighted by the artist. Defendants asked to purchase the rights to reproduce the images for display on the Internet, but Plaintiff refused the request.
- Subsequent to this conversation, the Alex Grey images were removed from the mystic 28. mana website and other websites on which Defendants were selling Alex Grey images. However, recently it has come to the attention of Plaintiff that Defendants again are using reproductions of Alex Grey images on the Internet in relation to the sale of Alex Grey posters.
- Plaintiff alleges that Defendants knowingly, willfully and deliberately reproduced and 29. misappropriated, and continues to do so, Alex Grey images for display on the Internet.
- 30. Given the obvious reproductions of Alex Grey artwork, there can be no dispute that Defendants has access to Alex Grey's images.
- Despite Defendants' knowledge of Alex Grey' valid copyright in the images, Defendants 31. continue to advertise, sell, exhibit, distribute and disseminate reproductions of the images willfully and in reckless disregard of Alex Grey's rights, and have profited through the aforesaid activities.
- 32. At no time has Alex Grey either licensed or assigned his aforementioned rights to Defendants or to any third parties that could then permit reproduction and exploitation of Alex Grey's rights by Defendants.

Defendants have at all times undertaken, and/or been responsible for, the creation, 33. production, financing, and distribution of the reproduced and copied images. Defendants plan to continue to disseminate the images in the aforesaid media for the foreseeable future.

DAMAGES TO PLAINTIFF CAUSED BY DEFENDANT'S CONDUCT

- The natural, probable and foreseeable result of Defendants' wrongful conduct has been 34. and will be to deprive Plaintiff of the benefits of exploiting his artwork, to deprive Plaintiff of goodwill associated with his artwork, and to injure Plaintiff's relations with present and prospective distributors.
- Upon information and belief, Plaintiff believes that he has lost and will continue to lose 35. substantial revenues from the sale of the illegal reproductions and will sustain damage as a result of Defendants' wrongful conduct. Defendants' wrongful conduct has also deprived and will continue to deprive Plaintiff of opportunities for expanding his goodwill and the sale of his artwork.

CLAIM I

COPYRIGHT INFRINGEMENT

- Plaintiff repeats and realleges each and every allegation set forth in paragraphs 1 through 36. 35, inclusive and incorporates same by reference, as if fully set forth herein.
- 37. Plaintiff has complied in all respects with 17 U.S.C. §§ 101 et seq., and secured the exclusive rights and privileges in and to the copyrights to the artwork and images set forth in Paragraph 20 and 21. Plaintiff has been and still is the sole proprietor of all rights, title, and interest in and to these copyrights.

- By its actions alleged above, Defendants have willfully, intentionally, and/or wrongfully 38. infringed and will continue to infringe Plaintiff's copyrights by displaying images of Alex Grey's artwork that are direct copies of Plaintiff's copyrighted work.
- Plaintiff is entitled to recover from Defendants the damages, including attorneys' fees, he 39. has sustained and will sustain, and any gains, profits and advantages obtained by Defendants as a result of Defendants' acts of infringement alleged above. At present, the amount of such damages, gains, profits and advantages cannot be fully ascertained by Plaintiff.
- Defendants' conduct violates the exclusive rights belonging to Plaintiff as owner of the 40. copyright, including without limitation Plaintiffs' rights under 17 U.S.C. Sec. 106.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff prays for judgment against the Defendants as follows:

- A That the Court finds that Defendants have infringed Plaintiff's copyrights.
- B) That judgment be entered for Plaintiff and against Defendants for Plaintiff's actual damages according to proof, and for any profits attributable to infringements of Plaintiff's copyright.
- C) That judgment be entered for Plaintiff and against Defendants for statutory damages due to Defendants' unlawful activities.
- D) That judgment be entered for Plaintiff and against Defendants for increased damages due to the willfulness of Defendants' unlawful activities.
- E) That Defendants be required to account for all gains, profits, and advantages derived from its acts of infringement.

- F) That all gains, profits and advantages derived by Defendants from its acts of infringement are deemed to be held in constructive trust for the benefit of Plaintiff.
- G) That Plaintiff has judgment against Defendants for Plaintiff's costs and attorneys' fees.
- H) That the Court issue a permanent injunction against Defendants using Plaintiff's artwork and images on the Internet or in any other manner that violates the rights of Alex Grey.
- I) That the Court grant such other, further, and different relief as the Court deems proper under the circumstances.






