**MOTION FOR ORDER ALLOWING PLAINTIFFS TO PROVIDE TRUSTEE
WITH DOCUMENTS OBTAINED IN DISCOVERY REGARDING
DEBTOR AND DEFENDANT BARBARA ROBBINS**

Lynn Hahn Martinez, Trustee of the Bankruptcy Estate of Barbara Robbins, hereby respectfully requests that this Court enter an order allowing Plaintiffs Karen Dudnikov and Michael Meadors to provide her with copies of all documents received from or regarding Plaintiff Barbara Robbins to her, and in support thereof, states as follows:

1. Debtor Barbara Robbins filed a voluntary petition for relief under Chapter 7 on October 7, 2005.
2. The Debtor and her attorney appeared at the Meeting of Creditors on December 7, 2006. Plaintiffs Dudnikov and Meadors also appeared at the Meeting of Creditors.
3. Plaintiffs filed this adversary proceeding, seeking to deny Debtor and Defendant a discharge of debts pursuant to §§523 and 727, and were successful. The Order denying Discharge entered on October 25, 2006 (Docket No. 46).
4. Plaintiffs have done extensive research regarding Debtor and Defendant, and provided the Trustee with the documents they thought were appropriate at and after the Meeting of Creditors.
5. The Plaintiffs will not provide the Trustee with documents they received as part of the discovery in this case based on the Court's Minute Order entered on July 21, 2006 (Docket No. 28). This Order provides, in pertinent part that "[t]he Plaintiffs must not reveal any document or information obtained pursuant to this order to any other person or entity, including agents of the Plaintiffs, experts or attorneys

retained by the Plaintiffs, or the public, via website, or otherwise, without further order of this Court.”

6. The Plaintiffs believe that the Court’s Order prevents them with providing the Trustee with discovery received from Debtor and Defendant, or regarding Debtor and Defendant, including but not limited to records from Park State Bank.
7. The Trustee is respectfully requesting the entry of an order allowing Plaintiffs Karen Dudnikov and Michael Meadors to provide her with discovery received from Debtor and Defendant, or regarding Debtor and Defendant, including but not limited to records from Park State Bank to assist her in collecting an liquidating property of the Bankruptcy Estate of Barbara Robbins.

WHEREFORE, Trustee Lynn Hahn Martinez prays that the Court enter an order allowing Plaintiffs Karen Dudnikov and Michael Meadors to provide the Trustee with discovery received from Debtor and Defendant, or regarding Debtor and Defendant, including but not limited to records from Park State Bank, and for such other and further relief as is just and proper.
